## Retail Gift Aid Agency Agreement



- 1. You are appointing **COPE Ltd** to act on your behalf in attempting to sell or dispose of the goods that you bring into our shop. The goods remain your property until they are sold.
- 2. On completing the **COPE Ltd declaration form** you are confirming that you are the owner of the goods which you have made available for sale and that you are not acting as a business.
- 3. Once you have signed the Gift Aid declaration form you will be given a **unique reference number**, which will be used to identify your donated goods so that we can track the money generated from the sale of your goods.
- 4. You confirm that COPE Ltd is instructed to donate the net proceeds of sale of your goods to COPE Ltd and that it is not necessary to write to you to confirm the donations, provided that the total value of the net proceeds of sale of your goods so far in the tax year has not exceeded £100 (or such higher amount as is specified by HM Revenue and Customs from time to time). Once a sale is made that brings the total value of the net proceeds of sale of your goods to more that £100 (or such amount as specified by HRMC from time to time), we much first write to you to confirm your consent to those funds over and above the initial £100 being donated. You will have 21 days from the date of notification to contact us for receipt of these funds. You may notify us in writing at any time (COPE Ltd, Post Business Park, Lerwick, Shetland, ZE1 0TW), if you no longer want this arrangement to apply.
- 5. An end of year letter informing you of the value of all goods sold on your behalf in that tax year will be sent to you before 31<sup>st</sup> May the following year. This is a requirement of HMRC in order to confirm your status as a tax payer during the year and therefore our eligibility to claim the Gift Aid.
- 6. Subject to you being a UK taxpayer, COPE Ltd will reclaim 25p of tax on every £1 of Net Proceeds generated on cash from the sale of your goods. The amount of Gift Aid claimed could be subject to change in legislation. To qualify for Gift Aid you must pay more Income Tax and/or Capital Gains Tax that the amount of Gift Aid Claimed on all your donations in the tax year and it is your responsibility to pay any difference.
